

Delivery Challan Book

Duplicate · 100 challans · serially numbered · Rule 55 CGST

This file contains the first two serials (001 and 002) as a proof, with all 2 copies of each. To make the full book of 100:

1. Take this file to any local press and ask for a duplicate book, 100 sets, serially numbered from 001.
2. Ask for carbon interleaving so one pen stroke marks all 2 copies.
3. Give them your business name, address and GSTIN for the letterhead block.
4. Standard binding is 100 sets per book, top-stapled with a card back.

Keep the sequence unbroken. A missing serial is the single thing most likely to be questioned at a check post or in an audit. If a challan is spoiled, write CANCELLED across all copies and leave them in the book.
